It has been identified recently that there may be some issues around the use of Term Contracts within the Roads Construction and Maintenance sector of Local Government.

Your Union, has fielded several phone calls from members who have questions regarding the repeated use of a Term Contract for positions on council which are externally funded. Upon investigation it was identified that these positions have been funded for the last 3 or more years from Transport for NSW as part of their RMCC contracts at local councils.

Due to the ongoing, repetitive and systematic nature of RMCC work, the Union is of the view that these positions should be made permanent positions on any structure.
